### Minutes - April 9, 1972 Meeting Resist Steering Committee

Attending the meeting were - Bell Chevigny, Judy Chomsky, Bill Davidon, Frances Eubanks, Frank Joyce, Paul Lauter, Todd Manley, Dick Ohmann, Grace Paley, Jennifer Riley, Jean Turner, Barbara Webster, Tom Wolfe, and Robert Zevin.

Financial Report - This month we have been getting returns from the resubcription effort amounting to \$2,927.00 Resubscription will continue through this month although it will be dropping off. This income plus the income that we should start getting from the next mailings probably will keep our income steady for May and June. Out of a total disbursement figure for April of \$7,188.07, about 58% went for grants, 24% for office overhead and salaries, and 18% for programs (newsletter, printing, and travelling expenses).

Staff Report - Tom Wolf has been hired as part of the staff. Todd plans to leave by the middle of April.

Mass Mailing - Staff will do a mailing of 3100 from the Spanish Refuge Aid list, which, was obtained by even exchange with our list. This list should go out by the middle of the month. Also, the week of April 24, we will be using 5000 names from the I. F. Stone list instead of the entire list of 61,000. It was decided to use only this portion after we found out that the list has been used altogether 12% times. Howeve, if these 5000 names do well, we can use the remainder at a later time. The I. F. Stone list was rented from the NYRB and will be sent out from a mailing house.

Newsletter - Keeping in mind that this issue will go to I. F. Stone's list as part of the contents of that mailing, it was decided to have an overview article on movement trials, and also articles on Vietnam and the Woodcutters' strike. If there is room something will be included about Armed Forces Day, past and presently planned actions.

Ad - Bell called David Levine during the meeting. He suggested we contact the NYRB for use of a cartoon that has already appeared in that magazine. Staff will make arrangements, where feasible for running the ad in The Phoenix, BAD, Ramparts, American Reports, etc. Barbara & also informed us that WTR would run an ad for Resist in their magazine.

Military Bases on Alert - Paul had with him an impressive list of U. S. Air Force and Navy bases placed on alert, or which had already begun sending men and equipment to the war zone. The list was compiled by the U.S.S.F. staff after having attended a meeting in Portsmouth of G.I. organizing project and support groups. By comparing notes, the groups realized that the government was planning a massive response to the North Vietnamese offensive. A conference of VVAW's at Austin, Texas further corrobosated this. A coordinating committee was set up called the Ad Hoc Military Buildup Committee to continue gathering information from AFB's around the country and to get the information to the press. This committee was to work out of the Legal In-service Project office in Cambridge. The staff took down this list. The general feeling was that Resist should help make this information public.

Interpretation of Events and Resist's Response - Frank said the U.S. may anticipate losing 20 planes a day. He thought the possibility should not be excluded of a military coup or a collapse of the Saigon government...Bill suggested that the information we have should be gotten to people abroad.

Paul urged that emphasis be laid on the fact the flow of men and materials is back to Vietnam. Frank, however, was concerned with what people in the movement should do as a response. Judy felt that emphasis should be put on making sure everyone (the people more or less sympathetic to the Left and the general public) knew what the U.S. was up to, and thought events should lead up to public forums about what was going on.

To this end, it was generally felt that Resist should etry to support and build for both the 15th and the 22nd, Frank making the point that if mass discontent evidenced itself and feelings against the war coalesed at some point, there would be needed vehicles there to transmit the spontaneity. Philadelphia people thought that they might change dates of local actions to not interfere with nationally planned demonstrations.

Paul suggested that Resist should use its ability of pulling academic people together for some action on the 15th in Washington. Several possibilities were thought of, including defoliating the White House lawn and the cherry trees, Grace being strongly against the latter. Paul quite seriously suggested that steering committee members should try to pull together the original group of Resist signers of the New Call, or part of that group for civil disobedience in Washington for the 15th.

In summary it was decided to send the information on the military bases on alert to the list of campus contacts for their use in teach-ins or whatever together with a cover letter urging people to some to the demonstrations in Washington and New York. Bill and Judy would put together a leaflet and would send it to the staff to go in the mailing highlighting recent events and the York, Pa. action.

The staff had to leave the meeting before it was over to catch the train. Discussion continued on making arrangements for the 15th.
