#### HAUTES FOR THE FEBRUARY @3rd MEETING

Present-Louie Campf(chairman), Bob Zevin, Nayne O'Neil, Eileen Atherton, Dick Ohmann, Joan Chomsky, Henry Recement, Hilde Hein, Joan Bromberg, and Larry Thomas.

Office Report- Wayne gave a report on the February Newsletter. A critisism of some complex terminology in Bob piece was but forth with the suggestion that a glossary be added in such cases.

The March newsletter was taken up. Larry and Joan will work on it. Possible atticles were discussed. Louie suggested a piece dealing with the danger of fascism with the economis failure with a historic background of how its happened in the past. Hank offered to address himself to that question and formulate an anarchist position from it for the April newsletter. Larry stated the Frank has a piece promised which would probably deal with the possiblities of fascism. Larry suggested a piece on the Puerto Rican conference which is taking place this weekend for the newsletter, noone objected. Bob promised to try and get the piece on unemloyment by Piven.

People talked about an Economic conference in Philadelphia this weekend,; a demonstration by deaerters in Washington marking the last day of clemency; and a Socialist teachers conference in New York all this weekend.

Mailing were taken up. APA mailing is doing good. Linguist mailing was stuffed at the meeting and will be posted this week. The CLLDF part of the big mailing will be stuffed this week, thats 2000 pieces so if any can help we urge you to do so, the USSF list we are still waiting for, Bob will continue to try to contact them, the MAI list is waiting Ken Coplans return which should be sometime this week.

Eileen asked permission to use financial reports and proposals for work experience credits at school and it was given.

Aprisoners group out of the Red Book who are starting up a newsletter for prisoners asked for our prisoners list and people agreed.

Bob was asked for any information on troop movements to South East

Asia and said he had nothing new but would watch for any developments.

Paul via Louie made a recomendation that we consider affiliation with a coalition of folks who make up the assembly to save the peace agreement and aksed if McCaulliffe from AFSC could come and talk with us about it at the next meeting in New York, people agreed to have him come.

Staff asked for a raise from \$115 to \$130 and it was granted.

Financial Report- Louie wanted to know what the Service Charge is and people suggested we open a \$5 saving acount if it means free checking, staff promised to look into it. Wayne stated that we shoudn't feel that we have to spend all our money withis month just because theres plenty.

Noam expounded on the Middle East, discussed the liberal expansionist ideology and its irrationality and how that conflicts with the conservative business interests. The nature of the PLO was discussed and some time spent on the internal domestic situation in least. At the end of the discussion we decided to run two articles in the newsletter by Noam, one on foreign policy and another on the domestic internal situation. The staff will shorten the article that was already sent out to people then send it to Noam for additions or depletions.

The next meeting was set for the 23rd of March in New York. A place hasn't yet been established.
