**RESIST Board Meeting**  
**Minutes**  
**February 3, 2008**

**Present:** Nikhil Aziz, Cynthia Bargar, Robin Carton, Miabi Chatterji, Diana Digges, Kay Mathew, Yafreisy Mejia, Jim O'Brien, Carmen Rau, Camilo Viveiros. **Attending:** Malika McCray, Christy Pardew.

**1. Agenda Review**

**2. Minutes of December Board meeting: Deferred**

December Board minutes were not available for approval and so were deferred until the April meeting for approval.

**3. Grants decisions/ Process**

\$41,500 was allocated. We had \$30,000 to spend. February is not as small a cycle as it once was. "Flattening out" now – we don't have huge spikes in proposals received. Total for non-full funding was \$15,000. Policy/practice in past – "everyone shares in the pain." Done not to overly penalize anyone.

Robin: Board can pick a target amount to put into pot. Finances: last year came out very well. Started January with a bang. Can we predict future funding this year – haven't seen evidence of downturn, but not sure we can replicate last year's fundraising successes. Balance to weigh. Did not have to use income from bequest as we could have. Have balanced budget on back of grant program in past.

Diana: past five years have not done well enough to go over the allocated amount.

Robin proposed: Let's add in to get to \$37,000. She will make best effort to allocate fairly and let us know. Cynthia seconded. Passed.

**Reflect, review**

- Diana: We had to rely on Robin. We seem to make grantees jump through lots of hoops.
- Camilo: Statewide groups – how can they coordinate? One person groups- many started that way, but what is transparency? Are they conscious of their role?
- Robin: Great process. Reminded of wealth of knowledge on the Board. Yafreisy and Robin will always play the intermediary role. Issue: is it too intrusive – power balance?
- Miabi: Exciting. Go through grants and see the work that's out there. Uplifting. Also dynamic seems healthy on Board.
- Jim: Better able to read the proposals this time-3<sup>rd</sup> meeting.
- Carmen: Always glad to be back.
- Nikhil: Energy and discussion always great. Three new people is great. Issue of not enough money nagging. Could we see some of the groups sometime that don't make it through?
- Cynthia: Great to have new people. Wished she had looked at websites of groups.
- Kay: Encourage people to write stronger proposals. Interesting and went smoothly.
- Yafreisy: Really enjoyed. Malika and Christy felt well-integrated. Appreciates Camilo all the time.
- Malika: Only good things to say. Question what we tell grantees.

(If Board says send a letter, we do. Otherwise, more general re partial – they then tend to call and Robin discusses.)



#### **4. Political Discussion:**

- Is this election really different from others or do we always say this because times seem so bad?
- Do progressive foundations like Resist have a role to play?
- How might the elections affect our funding and our grantmaking?

Not much discussion. Not a topic that inspired us.

#### **5. Committee Business:**

##### **a) Finance**

Ended 07 well. Did very well in December. Also in January. New prospecting package (David and Goliath) did very well. Pledges have gone up and 40<sup>th</sup> anniversary fundraising of course added to the success of 07. Some direct mail lists that we used include: Pathfinder Intl.; Grassroots, Rosenberg Fund for Justice, STITCH and more. Some first time donors gave \$1,000.

Catherine Brady is now on the Finance Committee. May need a CPA on our finance committee or staff under new financing regulations.

##### **b) Fundraising**

Committee just met. Donors at every level have been increasing their giving. Hit 1% benchmark with prospect mailing. Bringing in about 600 new donors per mailing.

In 2006 a lot of donors lost jobs, were affected by stock market (fewer shares or value of shares didn't remain constant between two years). Mailings weren't doing that well in 2006. Also decrease in number of newsletters sent (due to shift to the e-newsletter) may have contributed to drop in income.

Re Board giving. Fundraising committee suggests that all members become pledges. There was discussion as to whether the Board should be required to donate a specific amount or not. Carmen suggests pledge forms for Board members at the next meeting. Nikhil noted that a 100% giving rate for Board members was critical in bringing in new donors.

##### **c) Communications**

Has not met yet. Working on scheduling a meeting in the next two weeks.

March/April issue of newsletter: Youth organizing

Immigration- Nikhil: important now.

Regional focus- Nikhil: region as opposed to theme would be good.

##### **d) Grants**

Coming up with revisions to applications. Will bring new recommendations to the next meeting. Cynthia will send a zip code website to committee to access diversity stats.

##### *Proposal*

In order to be eligible to apply for a multi-year grant, an applicant must have received the maximum funding available for its most recent general support award.

We still need to find an at-large member.

### *Recruitment*

What is the ratio for people of color/white board members? What is the wording/intent of past board decisions? The R&R committee will evaluate past minutes and present this discussion again at the April meeting.

The Board voted to invite Jen Wilsea and Warren Goldstein-Gelb to join the board, but they will start after 2 people of color have been recruited. We are in the process of recruiting Melissa Carino and Sarath Soung. Nikhil suggested recruiting Mezhu Lui, Juan Leyton, and Guillermo from Solidaridad. Malika will follow up with him.

We ran over time, so Board members will email Malika their evaluations of Board duties.

**1. Review of Financial Statements**

Pledge program and prospecting income are better than expected.

Is it possible to track web income that is unrelated to prior gift-giving?

The Communications Committee may want to consider sending a press release to the philanthropic press regarding the 40<sup>th</sup> Anniversary grants and the responses. Recent articles portray those with general support and multi-year grants as trend setters- RESIST has been doing this for a long time under the radar.

**2. 2008 Budget and Recommendations for Adjustments**

No changes were proposed. The Budget will be submitted to the Board again for a second vote in February.

**3. Charitable Filing Status**

About half of the states have received filing applications. Some have registered RESIST, some have raised concerns and need additional data. Nancy Greenhouse, our direct mail consultant, may have to register in a number of states as well.

**4. 40<sup>th</sup> Anniversary Fundraising**

See 40<sup>th</sup> Anniversary spreadsheet attached. In addition to terrific fundraising, RESIST gained great experience around events and auctions. Perhaps a November auction might be considered.

One result of the event was that RESIST grantee EPOCA was featured at a Jobs for the Future event.

**5 Three-Five Year Financial Plan.**

Meredith will put together a list of things that need to be considered as a part of three-year planning. The Finance Committee will review the list and ask other committees for input as part of the planning process (e.g. grants, fundraising and personnel needs). The target is to have a discussion in March and finalize the plan by June. Catherine will work with Robin and Yafreisy on this.

**6. Fundraising Report**

Nancy Greenhouse met with the staff to provide a Direct Mail 101 training regarding prospect and renewal mailings. This year there will be four renewal mailings and two prospect mailings.

The Committee felt that it would be fine for Carol to continue to come in one day per week to complete training as necessary. Carol may also end up consulting on any significant changes to the pledge program.

## **BIG PICTURE**

Our *net income* (income less expenses) for January 1, 2007, through December 31, 2007, was a *gain* of about \$76,764. In our annual budget for this time period, we expected to have a net gain of \$22,613.

*Income* is higher than expected by \$137,478. *Expenses* are approximately \$80,759 more than anticipated. This means we have a difference of approximately \$54,151 between where we expected to be at this time and where we actually are. For the most part, higher expenses reflect an increase in grantmaking of approximately \$60,000 and pre-paid expenses for 2008 that were incurred in 2007.

Bottom line: Based on these figures, the Finance Committee has no recommendations for amending the annual budget or revising operating plans for the year.

## **STATEMENT OF NET ASSETS (ITEM A)**

At this time, we have assets of approximately \$725,292. This is about \$67,633 more than we had in 2006. The increase in assets is primarily due to: 1) income generated from the bequest of the Estate of Phillip Schleimer; 2) an additional \$28,759 from the Estate, which was received in April, 2007; 3) higher than expected returns from 40<sup>th</sup> anniversary fundraising; and 4) higher than expected returns from direct mail fundraising.

## **STATEMENT OF NET ACTIVITIES (ITEM B)**

### ***Revenue:***

Revenue is about \$137,478 higher than budgeted: \$792,628 actual vs. \$655,150 in the budget.

#### Gifts and Pledges: \$123,234 higher than budgeted

- *Internal mailing* contributions are approximately \$8,933 less than budgeted. Income from the pledge program and appeals to current donors is higher than expected. Revenue from the *Newsletter* is \$40,117 lower than expected.
- *Prospect mailing* contributions are \$30,166 more than budgeted. This is probably because of the use of a new test packet, the timing of the mailing and a strong set of returns.
- *Special Contributions* are \$64,610 higher than budgeted. Employer matching grants contributions were slightly lower than expected. Unsolicited contributions were significantly higher than expected (\$64,384 over budget). A \$10,000 grant from the Bardon-Cole Foundation was received.
- *Special Events* income is \$37,392 more than budgeted. This is primarily due to gifts from individual donors and funds raised from the auction.



Investment Income: \$12,055 higher than budgeted

- *Interest and dividends* are \$8,682 higher than budgeted.
- *Realized gains or losses* on the sale of investments are \$395 more than budgeted.
- *Unrealized gains or losses* on investments are \$4,963 more than budgeted.

**Expenses:**

Expenses are about \$80,759 more than budgeted: \$741,296 actual vs. \$660,537 in the budget.

Fundraising expenses: \$17,279 more than budgeted

- *Internal mailing* costs are about \$1,970 more than the budgeted amount.
- *Prospect mailing* costs are \$12,768 more than budgeted. The increase in prospect mailing costs reflects a third round of prospect mailings to maximize income in 2007.
- *Other fundraising* costs are about \$2,540 more than budgeted. These increases reflect higher than expected costs for the 40<sup>th</sup> Anniversary event.

Program expenses: \$6,649 less than budgeted

- *Grants Program* expenses are \$69,141 more than budgeted. General support grants are above budget by \$57,050. This reflects the decision to award an additional \$40,000 in celebration of the 40<sup>th</sup> Anniversary and an additional \$20,000 in the December grant cycle. Multi-year grants exceeded budget by \$18,000. Technical assistance grants were under budget by \$2,500.
- *Newsletter* costs are \$1,987 more than budgeted. This reflects the timing of bills received for printing costs and postage.
- *Web site* expenses are \$876 less than budgeted.

Administrative Expenses: \$1,708 less than budgeted

- *General and administrative* expenses are \$2,238 less than budgeted. This reflects the timing of accounting fees, rent payments, the donor database subscription, and property insurance increases.
- *Personnel and health insurance* expenses are \$2,358 less than budgeted. This primarily reflects the timing of pay periods and \$800 in unused staff development funds.
- *Board* expenses are \$935 less than budgeted. This reflects lower costs across the category.

**Big picture: review of 2007 fundraising, donor demographics and identifying healthy proportions**

- The big picture of 2007 is that Resist had a very good year, with increases in renewal responses, acquisitions, major gifts, overall funds and a total of 1700 new donors in the last two years. The boom was likely due to anniversary excitement/giving, but there may be other factors.
- We could do an inquiry into age demographics, or we could just widen the scope through planned giving and e-fundraising, and we should focus on both equally
- According to a Jan/Feb 06 article in the Grassroots Fundraising Journal on how to evaluate funding proportions, Resist is doing well.

**Role of the fundraising committee and diversity of funding sources**

- There are two main categories for the role of the committee -- to assist new development staff and to do actual fundraising/find ways to motivate the rest of the board
- Two main areas that we want to actively pursue are events (especially house parties) and e-fundraising
- Mandy Carter wants to do a house party in North Carolina, Marc may work with her on that
- Carol will talk to Highlander Center for insight into house parties, Diana to Appalachian Community Fund
- Follow-up is very important for events, which we still need to do for the 40th
- As far as e-fundraising, Malika and Christy are beginning to meet about ideas

**Composition of fundraising committee**

- We need to think about what skills we still want – someone who is tapped into e-fundraising? Long-time supporters of Resist? Specific fundraising skills?

**Board Fundraising**

- Board shouldn't be required to donate a certain amount, but they should be encouraged to help fundraise
- For events, we could pair up a member of the fundraising committee with a member of the board
- We should encourage board members to look at their travel schedules and to think about making connections related to Resist when traveling (by bringing the newsletter, planning house parties, etc)

- With a diversified funding plan, we can be creative with asking board members to do things other than ask for money
- We should ask board members again to become pledge supporters

#### **Next Steps**

- Malika will prepare a list of the major donors from the 40<sup>th</sup> anniversary for the next meeting
- Malika and Diana will ask board members to look at their travel schedules and to consider pledging
- Diana will contact the Appalachian Community fund to get ideas/insight on house parties
- Carol will contact the Highlander Center
- Everyone will continue to think about what an additional person could bring to the committee

There is a lot of discretion- so the outcome is not predictable. Is this both unfair to the applicant and does it weaken the value of question #11?

*Recommendation:*

Include in the Board packet the prior letter raising concerns and enable the Board to look at the issues and the current positions. If the group sends a letter in response- include that as well.



### **3. Standards for the Multi-Year Grant Program**

Original Proposal: *In order to be eligible to apply for a multi-year grant, an applicant must have received full funding for its most recent grant award.*

10/07: Intent approved but new language needed to clarify the meaning of "full funding."

New Proposal: *In order to be eligible to apply for a multi-year grant, an applicant must have received the maximum funding available for its most recent general support award.*
