# REGULAR MEETING OF BOARD OF TRUSTEES.

# Committee on Election of President Reports Progress.

The regular meeting of the Trustees of Trinity College was held last Saturday. The committee to choose a permanent president reported progress. Physical training was discussed and it was stated that the present system of training for the four classes would remain. The trustees present were William C. Curtis, '75, Sydney G. Fisher, '79, Robert Thorne, '85, George D. Howell, '82, E. Kent Hubbard, '92, Wm. G. Mather, '77, Samuel Ferguson, '96, Shiras Morris, '96, Edgar F. Waterman, '98, Charles G. Woodward, '98, and Acting President Henry A. Perkins. The next stated meeting of the Board of Trustees is in April.

### WIRELESS TELEPHONE IN JARVIS LABORATORY.

### Professor Perkins and Tuska, '19, Conducting Experiments.

Professor Henry A. Perkins, in conjunction with Clarence D. Tuska, '19, has erected a wireless telephone apparatus in the Jarvis Physics Laboratory and they have the telephone working so that messages can be readily sent from one room in the laboratory to another. It is planned to set up stations on opposite sides of the campus and test out the apparatus over a greater distance in the near future. The apparatus with which the experiments have been made has a range of about ten miles.

During the week the wireless antennae, belonging to the wireless department of the college, will be set up between Jarvis Laboratory and Boardman Hall. If the half course in wireless is given this year, it is likely that Tuska will teach it. He studied at Trinity for two years and went into the army, being an instructor in wireless at a signal corps camp in Texas. Before the war he published a paper devoted to the interests of wireless amateurs and was active in the Relay League, an organization of amateurs through which messages were relayed from one operator to another, the continent being spanned in this way. The government re-strictions of amateur wireless sending and receiving have now been removed.

#### Freshman Bible.

The "Freshman Bible" staff has been organized with R. D. Byrnes, editor-in-chief; J. M. England, business manager, and M. D. Graham, secretary. The work was assigned as follows: Puels will cover undergraduate activities; Clapp, athletics, and Hungerford, the faculty.

# TRINITY DEFEATS WORCESTER BRUCE, LYNCH AND PIERCE SHINE IN 20 TO 7 VICTORY.

Trinity downed Worcester Tech Saturday at Worcester, 20 to 7, outplaying the Worcester team in all departments of the game. Trinity went in the game with lots of fight and the outcome was never in doubt. The Blue and Gold eleven threatened the other goal all through the game. The Trinity team was handicapped by the loss of Breslin and Foley and injuries received during the game compelled the retirement of Dolan, Miller and Jackson. Breslin was on the sidelines and too much credit cannot be given to him and Coach Shepherd for the spirit which they instilled in the team.

Hicks was playing his first game at center and, while one of his passes paved the way for Worcester's only score, he played good football. Miller was injured so that he was unable to finish the game, but played a good game while he was in the lineup. The big offensive star of the day was Bruce. He ripped wide holes in the Tech line and tore around the end for long gains time and time again. He took the ball over the line for the first score, dodging between two defensive halfbacks by such a narrow margin that they crashed into each other

The second Trinity score came in the same period—the second—when Johnson came in and blocked a kick and Pierce grabbed the ball, loped along, shaking off would be tacklers until he tripped over the goal line. The last score came in the final period when Worcester desperately threw a forward pass and Tenney intercepted and ran fifteen yards for a score.

Lynch ran his team in a brilliant fashion and easily outkicked his opponent. Jarvis and the other backs played stellar football all through the game. The ends especially Black, were a big factor in cutting down Worcester men, stopping end runs for losses many times. Dolan and Jackson starred on the defense, making a practically impregnable wall against which Worcester backs threw themselves only to bound back.

The game opened with Johnson sending a beautiful kick to Needham, who ran it back from his five to his twenty-five yard line. Trinity took the ball on downs and when they failed to gain, Jarvis tried to drop kick. A Worcester man caught the ball on his five-yard line and ran it back twenty yards. Needham was forced to punt, Lynch getting the ball on his twenty-yard line. He fumbled but recovered with no gain. Offside penalties prevented Trinity from making it a first down and Lynch punted to Worcester's twenty-five

yard line, five yards being made on the run back. Worcester made first down, but when the Trinity line held and the Blue and Gold received the ball on downs. Trinity lost more ground on offside penalties and Lynch punted, Tansill getting the man on his twenty-yard line without his having gained an inch. Worcesfumbled and Trinity recovered, ter eighteen yards from her opponent's Hicks made a bad pass and goal. the ball rolled well into Trinity territory, accelerated by ill-aimed dives by various players of both teams. White of Worcester finally recovered the ball and rushed it over for a score. Manning kicked the goal. Johnson kicked to Worcester's fiveyard line and Dexter ran the kick back five yards. Wth six minutes to play, Worcester kicked to Lynch and he ran the ball back to Worcester's twenty-yard line. Line plunges by Jarvis and Lynch gained, and then Bruce shot between tackle and guard for Trinity's first score. Johnson's boot added another point. Then his kickoff was run back to Worcester's twenty-yard line. Tech was forced to punt and Lynch got the ball to his forty-yard line. Bad passes lost ten yards and Lynch kicked to Worcester's thirty-yard line. The home team could not gain and Johnson blocked its attempt to kick, Pierce recovering the ball and scoring. Johnson missed the goal. Worcester kicked to Trinity, Hicks getting the ball and being downed on his fifteen-yard line. Trinity made a first down and brought the ball to her thirty-yard line. Time was called before Trinity had a chance to run off more than one play.

Johnson kicked off to Worcester at the beginning of the second half and the rival team put the ball in play on her twenty-five yard line. She made two first downs in succession, but the brilliant work of Black and Jackson set the Tech team back ten Needham punted to Lynch vards. and he was downed on his twentyyard line. Hicks made a poor pass and it was recovered by Trinity on her ten-yard line. Trinity was penalized for offside, bringing the ball to the five-yard line. Lynch punted to mid-field. Worcester made a first down just before time was called.

Worcester was forced to kick at the beginning of the last quarter. The home team held and Lynch punted. Worcester failed to gain through the line and tried a pass which was intercepted by Tenney, who ran fifteen yards for a touchdown. Johnson kicked the goal. Arthur ran the kickoff back to his twenty-five-yard line, being downed by Puels. Worcester

# ALUMNI GATHER AT DETROIT. Detroit Alumni Entertain Convention

Detroit, October 23, 1919.

On Monday evening, October 20, the Trinity alumni of Detroit entertained the graduates of the college who were in the city as delegates to the Triennial General Convention of the Episcopal Church. The form of entertainment was a dinner held at the Detroit Club. Fifty-five Trinity men were present.

The proper spirit was given to the occasion at the very beginning, when the music struck up "'Neath the Elms", as the guests entered the dining room. The tables was appropriately decorated with vases of violets and marigolds, and copies of favorite Trinity songs tied with blue and gold ribbons were at each place.

Sidney J. Miller, '85, was the toastmaster. Speeches were made by Rt. Rev. C. T. Olmsted, '65, Colonel W. S. Coggeswell, '61, Rev. J. B. Cheshire, '69, Rt. Rev. F. F. Johnson, '94, Rt. Rev. T. P. Thurston, '91, Rev. E. M. Stires, '01 (H), and Rt. Rev. Charles Brent, who, although not a Trinity man, is well known to them all, especially to those who served in the A. E. F., of which he was Chaplain-General. His talk is mentioned especially because its subject is peculiarly apt for Trinity in its present search for a new president. "Leaderwhich Bishop Brent spoke ship". about, became the watchword of the evening. According to Bishop Brent the true leader is not the man who thinks ideas apart from other men and superimposes his thoughts upon them, but rather he, who, knowing his fellows thoroughly and sympathetically, goes along with them, helping them to find the right road.

# HOW TO READ THE NEW SUNDIAL.

Professor Fischer has worked out the following directions for reading the sundial.

Now that the summer time has been replaced by the usual winter schedule, the sundial will indicate within a few minutes the actual standard time for Hartford, and those who wish to set their watches within five minutes by the sun can do so by observing the following directions:

The shadow of the point of the gnomon is the index and the lines cut at the lower edge of the halfcylinder stand for various intervals of time. The longest lines are the hours (noon being directly on the gnomon); the next longest are halfhours; still shorter ones indicate tenminute intervals; and the very short ones at the edge of the cylinder come every five minutes. During the morning the shadow lies on the left of the noon mark, so that, for instance, ten minutes of eleven would be the second of the smallest divisions to the left of the first hour line before noon.

The mean solar time for Hartford differs from standard time by a fixed amount and as there is a variable difference between apparent solar time as indicated by the sundial and mean solar time, a variable correction must be used which differs for every day in the year.

The following are the corrections for the first day of each month and corrections at other times can be estimated by taking values between that for the first of each month and of the month succeeding:





# DOCTOR URBAN LEADER.

Professor W. M. Urban has been appointed leader of the discussion at the nineteenth annual meeting of the American Philosophical Association, to be held at Cornell on December 30 and 31. He has chosen as leaders Professor Roscoe Pound of Harvard, Professor Harold J. Laskey of Harvard, Miss Mary P. Follett of Boston, Professor J. H. Tufts of the University of Chicago, and Professor Norris R. Cohen of the College of the City of New York. The main topic of this year's meeting will be "The Nature of the Community." The papers of the leaders will be printed in the forthcoming (November) number of the "Philosophical Review."

Professor H. M. Dadourian, of the Trinity Physics Department, published a paper on "Soft X-Rays" in the September number of the "Physical Review." He is planning to continue his studies of the characteristics of X-Rays and of the elements of low atomic weight and is now assembling his apparatus. Thomas R. Shepherd, a former football star at the University of Maine, has been engaged as coach for the Trinity football team and assumed charge of the squad Thursday. George S. Buck, who has been coachng the team this fall, has been forced to resign on account of the press of other business. The new coach has not had time to give the team anything except an intensive drill on the fundamentals and on the old formations.




