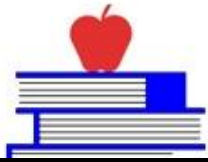

Eligibility Requirements

- Students must reside in Hartford, Bridgeport, or New Haven
- Applicants must be within 200 percent of the federal poverty guidelines for their household size
- New Applicants must be in grades K-5; Renewal Applicants must be in grades K-8

Scholarships to Private and Parochial Schools

- Eligible applicants receive scholarships that are worth half of their annual tuition, up to a maximum of \$1,700 per student
- In 2004-2005, 567 students were provided scholarships to 24 Hartford-area schools, 16 Bridgeport-area schools, and 7 New Haven-area schools

Eligibility Requirements: You must currently reside in Hartford, Bridgeport or New Haven. Your student must be in grades K-5. Your household income must be at or below the limits listed for your household size:

Household Size 2 – Income Limit = \$26,000
Household Size 4 – Income Limit = \$40,000

Household Size 3 – Income Limit = \$33,000
Household Size 5 – Income Limit = \$47,000

(for larger households, add \$7,000 per person)

Instructions: Complete, sign and mail this application to the address shown above. **Attach copies of all household wage earners' 2004 IRS 1040 forms.** If you did not file a 1040 form, you must provide us with a signed affidavit stating that no one in your household filed a 2004 Form 1040 and explaining the reason why no filing was made. Attach evidence of unemployment, copies of DSS or Social Security Administration budget sheets or checks, etc. **Please note that W-2 and pay stubs are not accepted.** Applications not accompanied by the required proof of income will be deemed to be incomplete and will not be considered until satisfactory income documentation is provided.

Completed applications will be considered on a first-come first-serve basis. Incomplete applications will not be processed. You will be notified in writing if you are awarded a scholarship. Scholarship awards are calculated as one half of actual annual tuition up to a maximum annual award of \$1,700 per student. Awards are paid directly to the schools.

I agree to the following terms and conditions in the event that my child is awarded a scholarship by Children's Educational Opportunity Foundation of Connecticut: 1) I will remain current on all tuition and fee payments to the school that my child attends; 2) Scholarship payments will continue only as long as my child is enrolled in a private or parochial school and attending school regularly; 3) All scholarships awards are made in the sole discretion of CEO Foundation of Connecticut; 4) I grant permission to the school I select to send CEO Foundation of Connecticut copies of my child's past, present and future school records; 5) I will promptly notify CEO Foundation of Connecticut of any change in address; and 6) I agree to release CEO Foundation of Connecticut from any liability in its efforts to provide this scholarship.

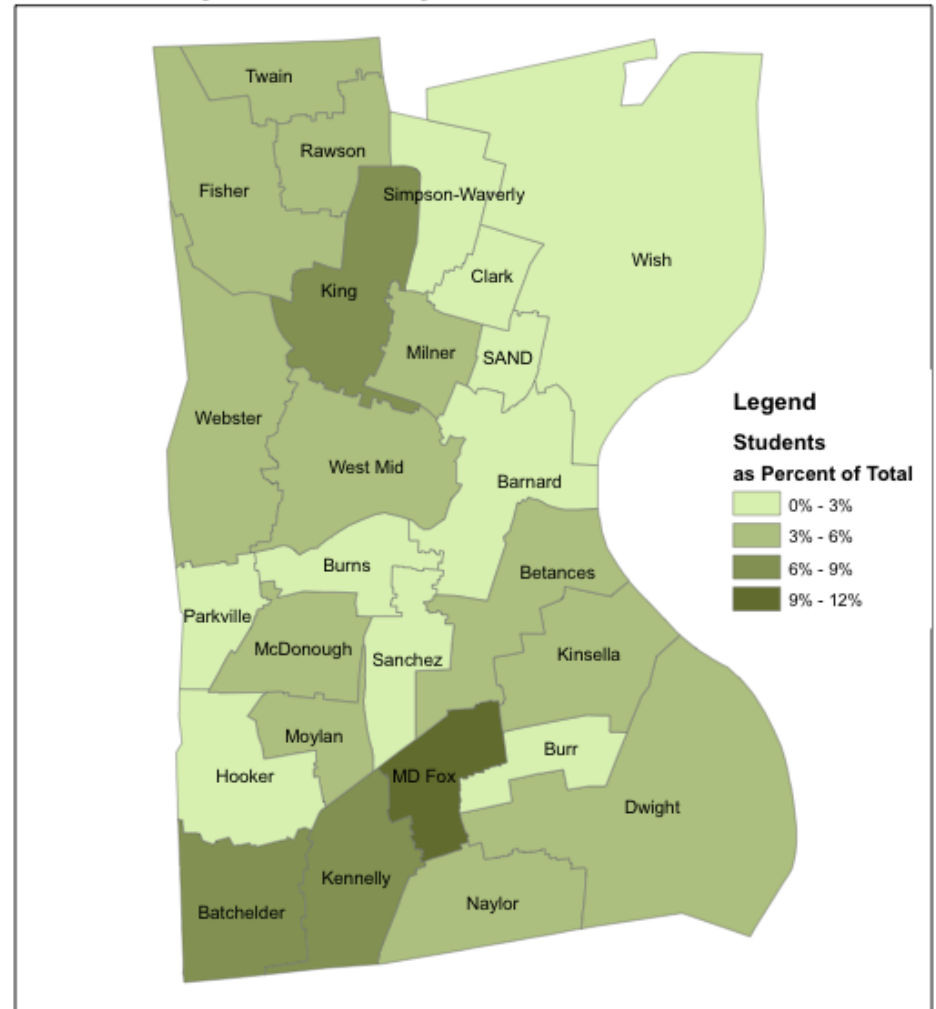

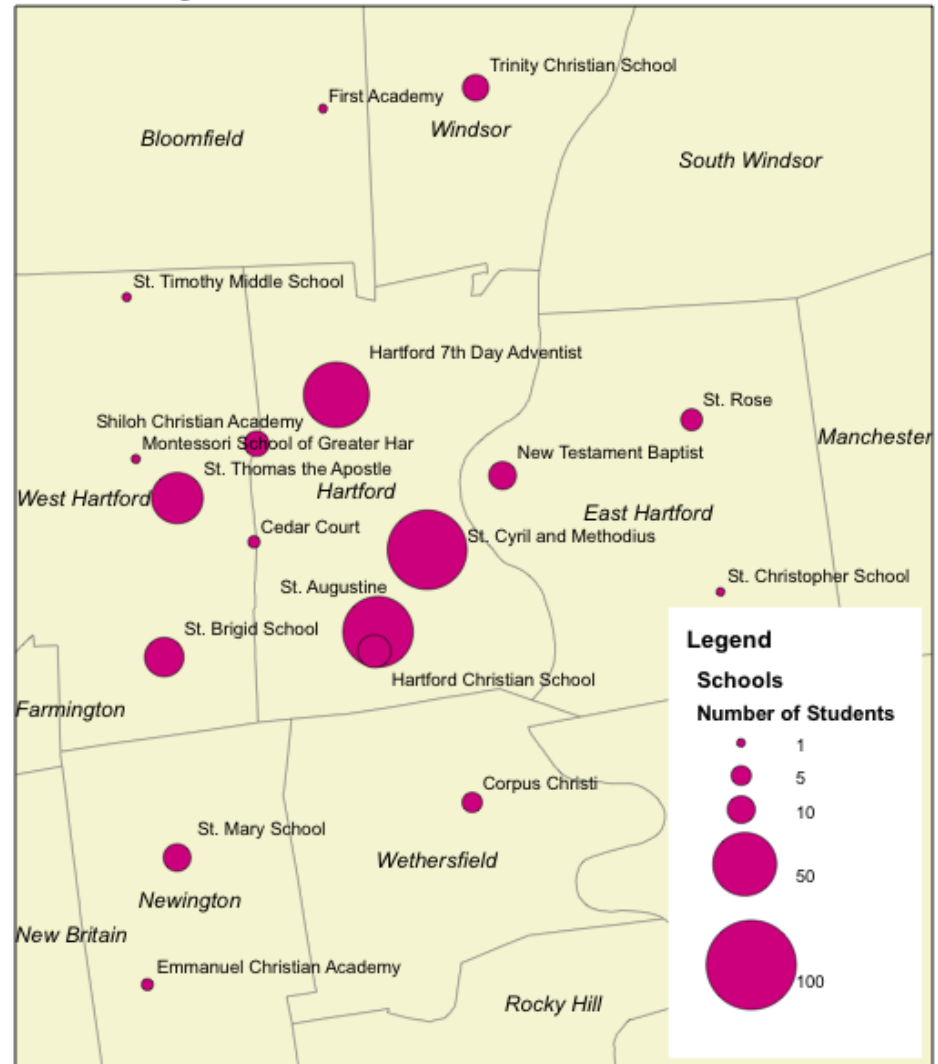

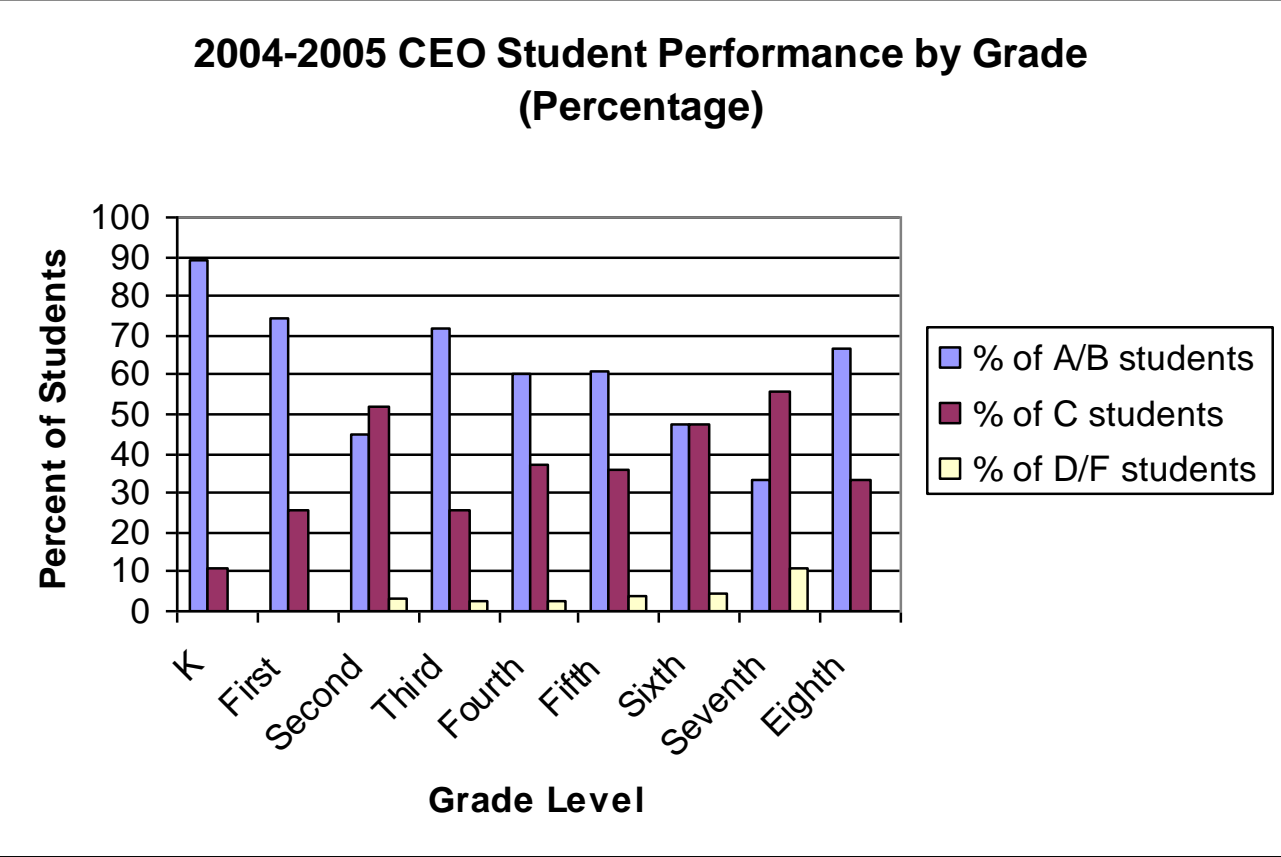

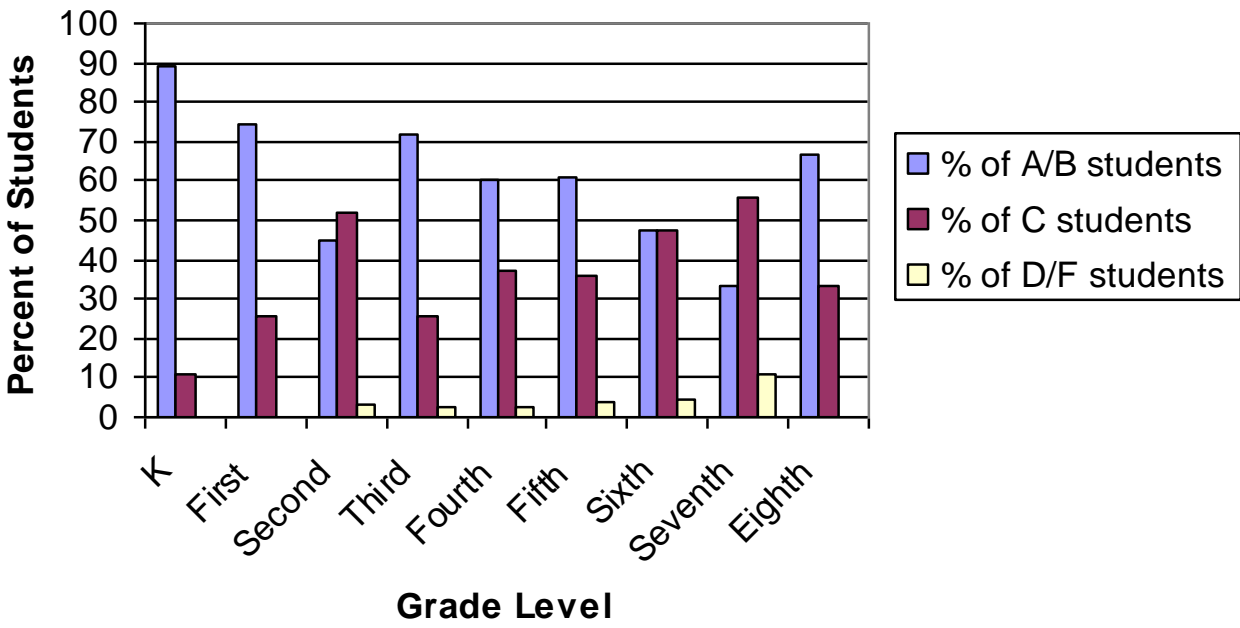
- CEO student grades cannot be easily compared with standardized tests (such as public school CMT scores)

2004-2005 CEO Student Performance by Grade (Percentage)

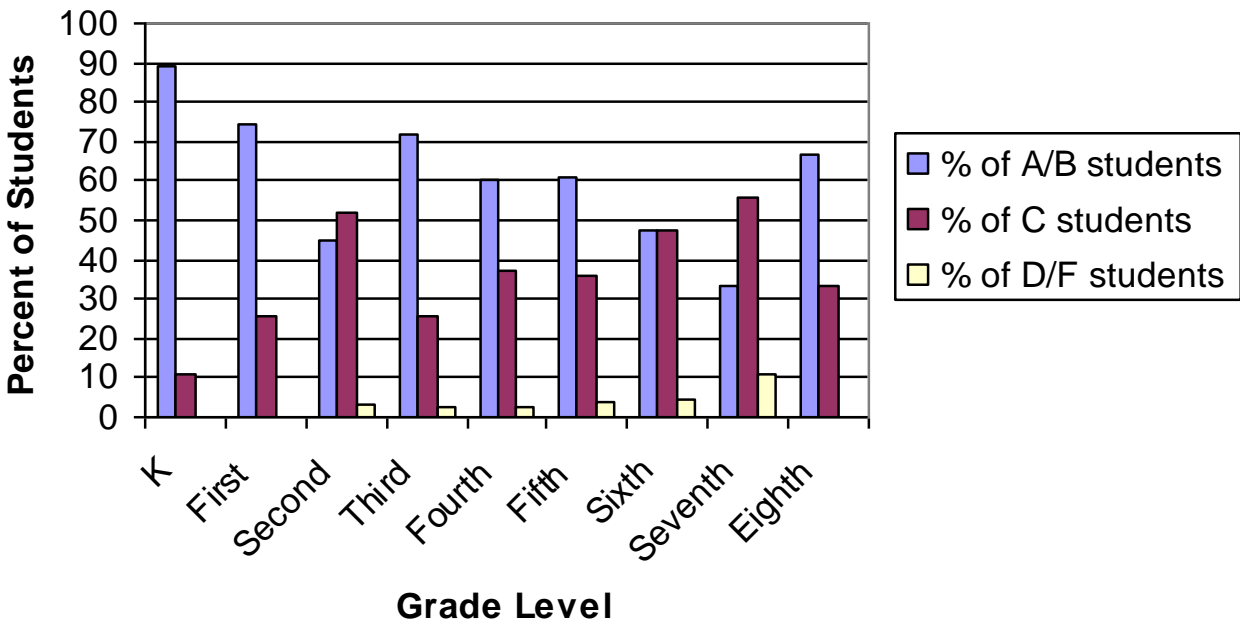

(Percentage)

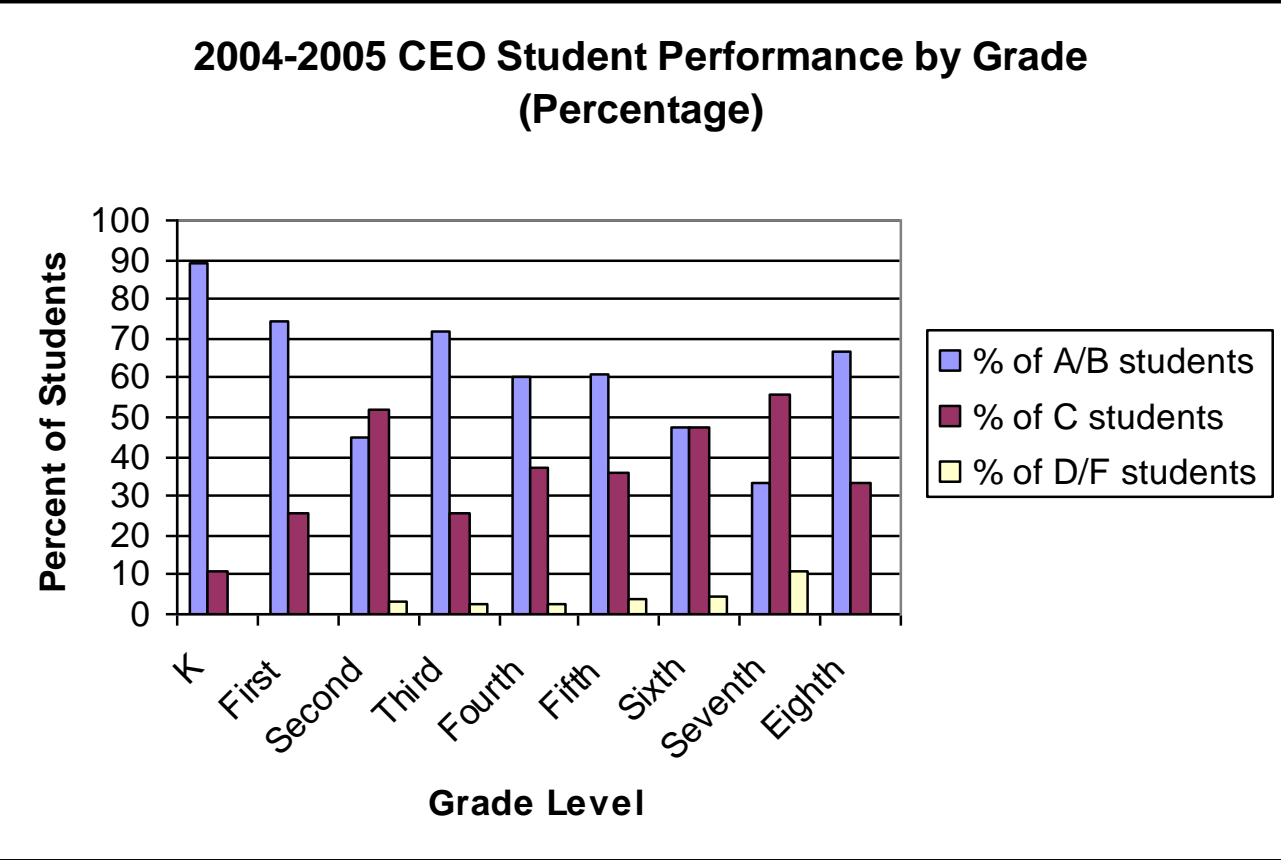
